Further enriching his expertise, he completed the

Specialization Course for Latin American Experts in Labor Relations at Universidad de Castilla-La Mancha, Spain.

Presently, he serves as Vice Minister of Labor Relations and Inspection at the Ministry of Labor.

He worked for Ecopetrol for approximately two decades, assumed the role of an arbitrator in legal disputes for the Company for more than 10 years, and his leadership within the Unión Sindical Obrera (USO) as the National Board Chair from 2018 to 2021 underscores his influential presence in the union labor domain.
